TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **Martha Freeman,**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Daniel J. Harkins and Stella Harkins**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **One Thousand Twenty-three and 36/100 - - -**

DOLLARS (\$ 1023.36),

with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid:

PAYABLE \$40.00 on March 24, 1956, and a like payment of \$40.00 per month until paid in full, with the right to anticipate payment, with interest thereon from date at the rate of **six (6%)** per cent. per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the Northwest side of Dixie Avenue, being known and designated as Lots Nos. 52 and 53, of a subdivision known as Dixie Heights as shown on Plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book H, at page 46, and described as follows:

BEGINNING at an iron pin on the Northwest side of Dixie Avenue, at corner of Lot No. 51, which point is approximately 309.8 feet North of the intersection of Dixie Avenue and Lowndes Hill Road, and running thence with line of Lot No. 51, N. 46-48 W. 150 feet to iron pin; thence N. 43-12 E. 100 feet to iron pin at corner of Lot No. 54; thence along line of Lot No. 54, S. 46-48 E. 150 feet to iron pin on Northwest side of Dixie Avenue; thence along the Northwest side of Dixie Avenue, S. 43-12 W. 100 feet to the beginning corner.

The above described property being the same conveyed to the Mortgagor by the Mortgagees by Deed recorded in the R.M.C. Office for Greenville County in Deed Book ____, at page ____.

It is understood that this Mortgage is second and junior in lien to Mortgage this day being given to Fidelity Federal Savings & Loan Association in the amount of \$3,500.00 to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
