To All Whom These Presents May Concern: I, T.H. Giles,

the Mortgagor(s), SEND GREETING: hereinafter called

WHEREAS, the said Mortgagor(s) in and by his certain promissory note in writing, of even date with these Presents, is well and truly indebted to

Five Thousand (\$5,000.00) ----- hereinafter called Mortgagee, in the full and just sum of DOLLARS, to be paid Ninety days from the date hereof,

with interest thereon from date at the rate of six per centum per annum, to be computed and paid in advance until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

The First National Bank of Greer, a Corporation, its Successors and Assigns:

All that certain parcel or lot of land situated on the corner of Vaughn Street and Gravely Road, near the limits of the City of Greer and northward therefrom, designated as Lot No. 10 of Pleasant View Acres according to survey and plat by H.S. Brockman, Registered Surveyor, dated February 19, 1954, recorded in Plat Book FF, page 365, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning at an iron pin, intersection of Vaughn Street and Gravely Road, and running thence along said Gravely Road, S. 58.33 W. 214 feet to an iron pin, corner of Lots 9 and 10; thence S. 2.00 W. 75.4 feet to iron pin; thence with the line of Lots Nos. 10 and 11, S. 88.00 E. 192 feet to an iron pin on west bank of Vaughn Street; thence with said street, N. 2.00 E. 80 feet, N. 0.09 W. 80 feet and N. 22 W. 37 feet to the beginning corner.
