sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its

on, situate, lying and being in the City of Greenville, County of Greenville, State
of South Carolina, being known and designated as Lots nos. 393 and 394, Pleasant
Valley, as per plat thereof recorded in the R.M.C. Office for Greenville County,
South Carolina, in Plat Book "BB", page 163; said lots having a frontage of 120 feet
