bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per  
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceed-  
ings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I , the said Alvin W. Johnson -----

----- in consideration of the said debt and sum of money  
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in  
consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and  
released, and by these presents do grant, bargain, sell and release unto the said Guaranty Mortgage Co.,  
Inc., its Successors and Assigns:

All that piece, parcel or lot of land in the City of Greenville, County of Greenville,  
State of South Carolina, being known and designated as Lot No. 383, as shown on Plat  
No. 5 of Pleasant Valley, prepared by Dalton & Neves, July, 1954; said plat is re-  
corded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "II",  
page 125, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Prosperity Court, which iron pin is  
the joint front corner of Lots 382 and 383, and running thence along the joint line  
of said lots, S. 50-09 W. 115.1 feet to an iron pin; thence N. 30-31 W. 91.1 feet to  
a stone on Prosperity Avenue; thence along the Southerly side of Prosperity Avenue,  
N. 60-43 E. 115 feet to an iron pin at the intersection of Prosperity Avenue and  
Prosperity Court; thence along Prosperity Court, S. 29-17 E. 70 feet to an iron pin,  
the point of beginning.
