All that certain piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, Chick Springs Township, being a small triangle carved out of the northwest corner of Lot No. 3 as shown on Plat of Property of W. P. and Mary M. Hall recorded in the office of the R.M.C. for Greenville County in Plat Book "Z" at page 8, and being a part of the same lot of land conveyed to ^{Ernest Willard Goodnough} by deed from W. E. Bannister May 10th 1942, recorded in the office of the R.M.C. for Greenville County in Deed Book 456 at page 37, and having the following courses and distances, to wit:

Beginning on an iron pin on the east side of Halcox Street, joint corner of lots nos. 2 and 3, and runs thence with the common line of lots 2 and 3, S. 76-12 E. 42.2 feet to a point on the said common line; thence a new line, N. 85-22 W. 41.1 feet to an iron pin on the east side of Halcox Street; thence with the east side of the said street, Due North, seven (7) feet to the beginning corner.
