securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the southwesterly side of Parker Road, near the
City of Greenville, S. C., and being shown as Lot No. 8 on the plat of Victor-
Monaghan Co. Development No. 1, as recorded in the RMC Office for Greenville County,
S. C. in Plat Book M, page 39, said lot fronting 92 feet on the southwesterly side
of Parker Road and having a depth of 275 feet on the northwesterly side, a depth of
275 feet on the southeasterly side, and being 92 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
