in the full and just sum of Two Thousand, Five Hundred and no/100 (2,500.00)

Dollars, in and by my certain promissory note in writing of even date herewith, due and payable ~~on the~~

day of 19

in equal successive monthly instalments of Forty-Eight and 34/100 (\$48.34) Dollars each, first instalment due and payable on the 28th day of May, 1956, and an instalment on the 28th day of each succeeding month thereafter until both principal and interest are paid in full, instalment payments to be applied first to interest and the balance to principal, with privilege of anticipating payment of principal or any part thereof at any time or times before maturity,

with interest from date at the rate of six per centum per annum until paid; interest to be computed and paid monthly annually, and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear:

for and in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The First National Bank, Greenville, S. C., a corporation, as Guardian for Stephen Neal Spratt, its successors and assigns,

all that tract or lot of land in Paris Mountain Township, Township, Greenville County, State of South Carolina, on the north side of Hunt's Bridge Road, and adjoining lands now or formerly of Minnie Wynn, Frank Bowling, and others, and containing one and three-fourth (1 and 3/4) acres, more or less, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the north side of Hunt's Bridge Road, and running thence N. 14 E. 7.62 chains to an iron pin in a settlement road; thence with said road S. 62 1/2 W. 4.14 chains to a bend; thence S. 7 W. 3.75 chains to an iron pin on Hunt's Bridge Road; thence with said road S. 50 E. 2.87 chains to the beginning corner.
