

PARCEL NO. 2:

ALSO, all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the East side of Markley Street, and being known as Lot No. 7 of the City Property of Thomas J. Turner, containing one-third acre, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin 3x on Rhett Street, one hundred (100) feet from corner of Rhett and Markley Streets; thence running along Rhett Street, N. 70 1/2 E. 50 feet to stake; thence about N. 19 1/2 W. 64 feet to a stake on Mrs. Lindsey's line; thence with her line, S. 71 W. 49 1/2 feet to an iron pin 3x; thence S. 18 1/4 E. 65 feet to the beginning corner.

BEGINNING at an iron pin at the corner of land now or formerly of T. Q. Donaldson and running thence along the Eastern side of Markley Street, S. 18 3/4 E. 74 feet to a stake at the corner of property now or formerly of T. J. Turner; running thence along the line of the Turner property N. 71 1/4 E. 98 feet to an iron pin; thence running N. 18 3/4 W. 74 feet to an iron pin on the Donaldson line and running thence along said Donaldson line S. 71 1/2 W. 98 feet to the beginning corner.
