four and one-half per centum (4½ %) per annum until paid, said principal and interest being payable

in Greenville, S. C. , or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty-One and 70/100

Dollars (\$ 51.70), commencing on the first day of

said lot fronting 95 feet on the southwesterly side of Crosby Circle and having a
