Douglas Wilson & Co.** in **Greenville, South Carolina** , or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Forty Six and 50/100-----** Dollars (\$ **46.50**), commencing on the first day of **July** , **1956** , and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **June** , **1976** .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville** State of South Carolina;

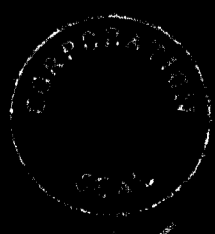
ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Alaska Avenue (formerly Morningside Drive), in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 5, on plat of Parkview Subdivision, made by Dalton & Neves, Engineers, June, 1942, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "M", at Page 49; said lot fronting 50 feet along the Southeast side of Alaska Avenue, and running back to a depth of 150 feet on the Northeast side, to a depth of 150 feet on the Southwest side, and being 50 feet across the rear.
