To ALL WHOM THESE PRESENTS MAY CONCERN: I, Daniel Athan Allen

of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co.

, a corporation organized and existing under the laws of South Carolina , hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ninety-nine Hundred Dollars (\$9900.00), with interest from date at the rate of four & one-half per centum (4½ %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S. C. , or at such other place as the holder of the note may designate in writing, in monthly installments of Fifty-five and 04/100 - - - - - Dollars (\$55.04), commencing on the first day of September , 1956 , and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August , 1981 .

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

All that lot of land in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 52 on plat of North Hills, recorded in plat book H page 138 of the R.M.C. Office for Greenville County, and having according to a recent survey made by R. W. Dalton, June 1956, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the southwestern side of Gallivan Avenue the front joint corner of Lots Nos. 51 and 52; thence with the southwestern side of said Gallivan Avenue N. 71-43 W. 69 feet to an iron pin; thence S. 12-37 W. 149.7 feet to an iron pin; thence S. 69-23 E. 50.7 feet to an iron pin rear corner of lot No. 51; thence with the line of said lot N. 19-17 E. 151 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
