WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twelve Thousand Eight Hundred Dollars (\$ 12,800.00), with interest from date at the rate of Four & One-Half per centum (4½%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy One and 17/100-----Dollars (\$ 71.17), commencing on the first day of September, 19 56, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 19 81.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Woodmont Circle, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 7 of Block "A", on plat of Brookforest, made by Piedmont Engineering Service, August, 1950, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "BB", at Page 41; said lot fronting 75 feet along the North side of Woodmont Circle, and running back to a depth of 152.7 feet on the West side, to a depth of 165.5 feet on the East side, and being 76.1 feet across the rear.
