TO ALL WHOM THESE PRESENTS MAY CONCERN:

RUTH P. ZIVKOVIC, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand Nine Hundred and No/100ths ----- DOLLARS (\$ 10,900.00 ), with interest thereon from date at the rate of five and one-half per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 61 of Augusta Acres, Property of Marsmen, Inc., on a plat recorded in the R. M. C. Office for Greenville County in Plat Book "S" at page 201, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the East side of Meadors Avenue, joint corner of Lots Nos. 60 and 61, and running thence with the line of Lot No. 60, N. 69-42 E. 200 feet to an iron pin; thence with the rear line of Lot No. 69, S. 20-18 E. 100 feet to an iron pin, joint corner of Lots Nos. 61 and 62; thence with the line of Lot No. 62, S. 69-42 W. 200 feet to an iron pin on the East side of Meadors Avenue; thence with Meadors Avenue, N. 20-18 W. 100 feet to an iron pin, the beginning corner.
