, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand Two Hundred and No/100-----Dollars (\$ 9,200.00), with interest from date at the rate of Four and One-Half per centum ($4\frac{1}{2}\%$) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co.

in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty One and 15/100-----Dollars (\$ 51.15), commencing on the first day of October, 19 56, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of September, 19 81.

ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of Hale Drive, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 7, Block A, on plat of Pinehurst, made by W. N. Willis, October 28, 1948, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", at Page 77; said lot fronting 60 feet along the Southwest side of Hale Drive, and running back to a depth of 143.9 feet on the Southeast side, to a depth of 144.6 feet on the Northwest side, and being 60 feet across the rear.
