To All Whom These Presents May Concern:

I, J.A. Walker

SEND GREETING:

Whereas, I, the said J.A. Walker  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to B.P. Edwards  
in the full and just sum of One thousand thirty-four and 46/100- - - - -  
(1,034.46)- - - , to be paid \$60.00 per month until paid in full--

, with interest thereon from date hereof  
at the rate of seven per centum per annum, to be computed and paid annually from date hereof  
until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that piece, parcel or lot of land in Chick Springs Township, Green-  
ville County, South Carolina, being known and designated as .34 acres,  
according to a plat of property of Lyda Ward, prepared by Dalton &  
Neves, in May 1953, and particularly described as follows:

BEGINNING at a point in Edwards Road at the Southwest corner of  
said property and corner of Whitmire property and running thence N. 87-40  
E. 199.8 feet to a post; thence N. 16-00 E. 78.5 feet to iron pin; thence  
S. 87-54 W 225 feet to a point on Edwards Road; thence with Edwards Road  
S. 4-42 E 70 feet to the point of beginning. This lot lies on the east-
