SEND GREETING:

Whereas, we, the said T.B. Posey, and wife Dorothy L. Posey

, to be paid in the following manner, \$45.00 per month

the first payment due October 10, 1956 and like amount each succeeding
month thereafter until the whole amount is paid in full,

, with interest thereon from date

at the rate of Six per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,

as Lot No. 46 as shown by survey of Dalton & Neves, Engs. made April,
1945 and marked Plat No. 2, property of W.S. Bradley. Said plat is of
record in the R.M.C. Office for Greenville County, in Plat Book "O"
page 169 and according to said plat has the following metes and bounds,
to-wit:

BEGINNING at a stake on the west side of Donnan Road
(Edwards Road) joint corner with Lot No. 45 and running
thence N. 88-10 W. 342 ft. to a stake joint corner with
Lot No. 43; thence S. 1-50 W. 100 ft. to a stake; thence
S. 88-10 E. 342 ft. to a stake on west side of Donnan Road
