TO ALL WHOM THESE PRESENTS MAY CONCERN: I, JOHN H. CHAPMAN, by MARIAN F. CHAPMAN, his Attorney-in-Fact of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

AIKEN LOAN & SECURITY COMPANY, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of FOURTEEN THOUSAND SIX HUNDRED Dollars (\$14,600.00), with interest from date at the rate of FOUR & ONE-HALF per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of AIKEN LOAN & SECURITY COMPANY in FLORENCE, SOUTH CAROLINA, or at such other place as the holder of the note may designate in writing, in monthly installments of EIGHTY-ONE AND 18/100 Dollars (\$81.18), commencing on the first day of NOVEMBER, 1956, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of OCTOBER, 1981.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in the county of Greenville, state of South Carolina, designated as Lot No. 14 on plat of Belle Meade recorded in plat book EE pages 116-117 of the R. M. C. Office for Greenville County and having according to said plat and a recent survey made September 1956 by R. W. Dalton, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Brookforest Drive, the joint corner of Lots Nos. 14 and 33; thence with the joint line of said lots S. 49-52 W. 98.4 feet to an iron pin; corner of lot No. 15; thence with the line of said lot S. 52-19 E. 140 feet to an iron pin on the northwest side of Williamsburg Drive; thence with the northwest side of Williamsburg Drive, N. 34-50 E. 65 feet to an iron pin; thence with the curve of said Street as it intersects with Brookforest Drive the chord of which is N. 13-10 W. 37 feet to an iron pin on the southwest side of said Brookforest Drive; thence with the southwest side of said Brookforest Drive N. 49-10 W. 90 feet to the beginning corner.
