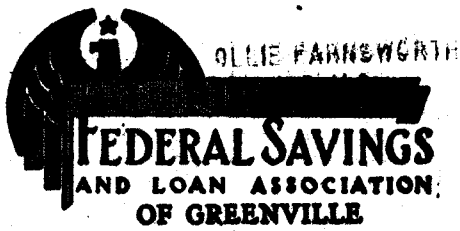

MORTGAGE OF REAL ESTATE

COUNTY OF Greenville

To All Whom These Presents May Concern:

I, John Robert McClure, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Fourteen Thousand, Three Hundred, Fifty and No/100 - -

(\$ 14,350.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of _____

Ninety and 80/100 - - - - - (\$ 90.80) Dollars

upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal. The last payment on this mortgage, if not sooner paid, will be due and payable twenty (20) years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as Lot No. 36 as shown on a plat of Morningside Subdivision, made by Dalton & Neves, Engineers, Dec. 1952, and recorded in the R. M. C. office for Greenville County, in Plat Book "EE", at pages 2 and 3, and also as Lot No. 36 as shown on plat of same property made by Dalton and Neves, Engineers, in Dec. 1952, which plat is of record in the R. M. C. office for said County and State, in Plat Book "FF", at pages 83, 84 and 85, reference to which plats is hereby made, said lot of land being described by metes and bounds as follows, to-wit:

"BEGINNING at an iron pin on the Southeastern side of Estanolle Street at a corner common to Lots No. 36 and No. 50 as shown on said plats, and running thence S. 26-46 E. along the dividing line between Lots Nos. 36 and 50, 217 feet, more or less, to an iron pin in the center line of a certain creek shown on said plats; thence following center line of said creek in a southwesterly direction, a traverse line of which runs S. 68-11 W. 151.9 feet to an iron pin on the Northeastern line of Richbourg Road; thence along the northeastern line of Richbourg Road, N. 40-32 W. 178.5 feet, more or less, to an iron pin; thence N. 10-09 E. following a curved line as shown on said plat, the chord of which is 31.2 feet to an iron pin on the Southeastern side of Estanolle Street; thence along Southeastern side of Estanolle Street, N. 61-32 E. 175 feet to the place of beginning; being the same conveyed to the mortgagor and Frances R. McClure by Marcel G. deLaRue, Jr. by deed dated October 14, 1955 and recorded in the R. M. C. office for Greenville County in Vol. 537, at page 59, the said Frances R. McClure having conveyed her undivided one-half interest in said property to the mortgagor by deed of even date herewith, not yet recorded."
