are incorporated herein by reference, in the principal sum of TEN THOUSAND FOUR HUNDRED & NO/100-
Dollars (\$ 10,400.00), with interest from date at the rate of four and one-half per centum
(4½ %) per annum until paid, said principal and interest being payable at the office of
Liberty Life Insurance Company in Greenville, South Carolina,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Fifty-Seven and 82/100- - - - - Dollars (\$ 57.82),
commencing on the first day of December, 19 56, and on the first day of each month there-

if not sooner paid, shall be due and payable on the first day of November, 19 81.

Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot No. 41 and the adjoining
one-half of Lot No. 43, Block B, Plat of Pinehurst, which plat is recorded in the
R.M.C. Office for Greenville County, South Carolina, in Plat Book "S", page 77, and
having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Pinehurst Drive, joint front corner
Lots 39 and 41, and running thence along Pinehurst Drive, S. 26-48 E. 90 feet to an
iron pin; thence through Lot No. 43, S. 62-23 W. 130 feet to an iron pin; thence N.
