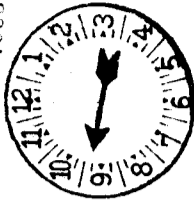

sold and released, and by these Presents do grant, bargain, sell, and release unto the said Cassie Lee Mayfield

All that certain piece, parcel or lot of land lying and being in Austin
Township, Greenville County, State of South Carolina, located on the North
East side of the Jones' Mill Road East of Simpsonville, S. C., and being more
fully described as follows: BEGINNING at an iron pin in the Jones' Mill road,
running thence N. 0-45 E 209 ft. to an iron pin; thence S. 89-15 E. 170 ft.
to an iron pin; thence S. 35-35 E. 651 ft. to an iron pin; thence S. 0-45 W.
1551 ft. to iron pin in Jones' Mill road; thence N. 89-15 W. 209 ft. to the
