TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Dorothy Rodgers,
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Eight Thousand and No/100 - - -
DOLLARS (\$ 8,000.00), with interest thereon from date at the rate of five
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the West side of Fore Avenue, near the City of Greenville, known as Lot No. 8, Block F, Section 3, on Plat of East Highlands Estates, made by Dalton & Neves, Engineers, May 1940, recorded in the R.M.C. Office for Greenville County in Plat Book K, at page 36, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Fore Avenue, at joint front corner of Lots Nos. 8 and 9 of Block F, and running thence with the line of Lot No. 9, S. 83-34 W. 135.6 feet to an iron pin on the East side of a 5-foot strip of land reserved for utilities; thence with the said reserved strip, S. 9-17 E. 38 feet to an iron pin; thence continuing with the said reserved property, S. 0-13 E. 69.7 feet to an iron pin on the North side of Laurel Creek Lane; thence with the North side of Laurel Creek Lane, N. 70-40 E. 144.3 feet to an iron pin at corner of Fore Avenue; thence with the West side of Fore Avenue, N. 6-26 W. 75 feet to the beginning corner.

The above described premises being the same conveyed to the Mortgagor by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 306, at page 108.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
