We, William H. Elmore and Alice E. Elmore of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

All that lot of land in the county of Greenville, state of South Carolina, designated as Lot No. 38 on plat No. 2 of W. S. Bradley, recorded in plat book "O" page 169 of the R.M.C. Office for Greenville County, and having according to said plat and a recent survey made October 1956 by R. W. Dalton, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the eastern side of Bahan Street, the front joint corner of Lots Nos. 38 and 39; thence with the joint line of said lots S. 88-10 E. 315.9 feet to an iron pin corner of Lot No. 51; thence with the line of said Lot S. 1-50 W. 99 feet to an iron pin in the line of Lot No. 12; thence with the line of lots Nos. 12 and 37, N. 88-10 W. 311.4 feet to an iron pin on the eastern side of Bahan Street; thence with the eastern side of said street N. 0-42 W. 99.1 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
