Dollars, in and by my certain promissory note in writing of even date herewith, due and payable

in thirty-six (36) consecutive monthly payments of \$228.17 on the 6th day of each month beginning December 6, 1956, payments to be applied first to interest and then to principal, until paid in full, final payment due November 6, 1959,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

A. Floyd, deceased, its successors and assigns:

All that certain tract of land in Chick Springs Township, Greenville County, South Carolina.

BEGINNING at an iron pin in the State Park Road, H. P. McGee corner, and running thence with State Park Road N. 21-15 E. 180 feet to a bend; thence still with State Park Road N. 27-45 E. 119.7 feet to iron pin a corner of tract sold to Dempsey; thence with Dempsey line S. 49-30 E. 368.5 feet to iron pin; thence still with Dempsey line N. 48-30 E. 300 feet to iron pin; thence still with Dempsey line N. 55-30 E. 70 feet to iron pin; thence still with Dempsey line N. 42-10 E. 82.5 feet to iron pin; thence S. 33 W. 220 feet to stone; thence S. 2-49 W. 936 feet to iron; thence N. 64-40 W. 452 feet to rock; thence N. 28-20 E. 107 feet to rock; thence N. 27-42 W. 508 feet to the beginning corner, containing 8.38 acres, more or less; being the same land conveyed to the mortgagor by deed of Rena L.
