, a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixty-Nine Hundred Fifty and no/100 Dollars (\$ 6,950.00), with interest from date at the rate of four and one-half per centum ($4\frac{1}{2}$ %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S. C. , or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-Eight and 64/100 Dollars (\$ 38.64), commencing on the first day of February , 19 57, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January , 19 82

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northwesterly side of Washington Loop, near the City of Greenville, S. C., and being shown as a portion of Lot 38 and all of Lot 39, Block D, on the plat of Washington Heights as recorded in the RMC Office for Greenville County, S. C. in Plat Book M, page 107, and having according to a more recent survey made by R. W. Dalton, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Washington Loop, joint corner with Lots 39 and 40, Block D, and running thence along the northwesterly side of Washington Loop S 56-27 W 52.95 feet to an iron pin; thence N 27-11 W 111 feet to an iron pin on the southeasterly side of Southern Railway right-of-way; thence along the southeasterly side of said right-of-way N 62-49 E 52.5 feet to an iron pin, joint rear corner of Lots 39 and 40, Block D; thence along the common line of said lots S 27-11 E 105.5 feet to an iron pin, the point of beginning. The southwesterly corner of the aforementioned property is located 1,762.45 feet in a northeasterly direction from the northeasterly corner of the intersection of New Buncombe Road with Washington Loop.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
