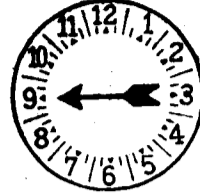

To All Whom These Presents May Concern:

SEND GREETING:

Whereas, I, \_\_\_\_\_, the said Gaynell Vinson Cowart  
 in and by my certain promissory note in writing, of even date with these  
 Presents, I am well and truly indebted to Bank of Piedmont  
 in the full and just sum of (\$271.47) Two Hundred Seventy-one and 47/100  
 , to be paid Payable one year from date

, with interest thereon from maturity  
 at the rate of 6 per centum per annum, to be computed and paid in advance  
 until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, that I, \_\_\_\_\_, the said Gaynell Vinson Cowart  
 , in consideration of the said debt and  
 sum of money aforesaid, and for the better securing the payment thereof to the said Bank of Piedmont  
 according to the terms of the said note, and also in  
 consideration of the further sum of Three Dollars, to me, the said Gaynell Vinson Cowart  
 , in hand well and truly paid by the said Bank of Piedmont

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Bank of Piedmont, its successors and assigns forever;

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, one lot lying and situated in Rehobeth School District, County and State aforesaid, adjacent to Highway Number 29 and being bounded by lands of the Grantor, Robert McJunkin, a dirt road and possibly others;

Beginning at point center of dirt road, joint corner of R. H. McJunkin and Grantor, thence down the dirt road 53 feet to a stake, thence in Eastern direction towards the Piedmont and Northern Ry. 164 feet to a stake, thence in a North East direction, 53 feet to point in or on line of Robert McJunkin and Grantor to a stake, (new corner), thence along line of Robert McJunkin 148 feet 6 inches to the point of beginning.

This being a piece, parcel or lot of land conveyed to Grantor by deed by Mell G. Guest, the 3rd day of May, 1948.
