WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand and No/100- - - - -

DOLLARS (\$ 12,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Humming Bird Circle, near the City of Greenville, being shown as lot # 59, on a plat of Wade Hampton Terrace, prepared by Dalton & Neves, March 1955, recorded in Plat Book KK at Page 15, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Humming Bird Circle, front corner of lot # 60, and running thence with the line of said lot, S. 18-51 E. 200 feet to an iron pin, rear corner of lot # 60; thence with the line of a lot marked excluded, and line of lot # 65, N. 71-09 E. 100 feet to an iron pin, rear corner of lot # 58; thence with the line of said lot, N. 18-51 W. 195.7 feet to an iron pin, on the Southern side of Humming Bird Circle; thence with the curve of the Southern side of said Circle, S. 80-29 W. 30.4 feet to an iron pin; thence with the Southern side of said Circle, S. 71-09 W. 70 feet to an iron pin, point of beginning."

Being the same property conveyed to the mortgagor by Gilbert Bentley by deed to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
