TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Lewis E. King and Beatrice M. King,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Gantt Township, near Gantt School House, and being shown and designated as Lots Nos. 11 and 12 on Plat of property of C. O. Berry recorded in the R.M.C. Office for Greenville County in Plat Book M, at page 29, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Hillcrest Drive, at the joint front corner of Lots Nos. 10 and 11, and running thence with the line of Lot No. 10, S. 3-05 W. 168.5 feet to an iron pin; thence along the line of Lots Nos. 30 and 31, N. 88-15 E. 100 feet to an iron pin on the Western side of Berry Avenue; thence with said Berry Avenue, N. 3-05 E. 172 feet to an iron pin on Hillcrest Drive; thence with said Hillcrest Drive, S. 89-50 W. 100 feet to the point of beginning.

The above described property being a portion of the same conveyed to the Mortgagors by A. J. Sewell, et al, by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 261, at page 434.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
