JOY J. PORTER AND GERALD T. CRAWFORD (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Richard C. Rudisill and Frances Rudisill (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Hundred and No/100 - - -

DOLLARS (\$ 1500.00),

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: \$35.23 on February 25, 1957, and a like payment of \$35.23 on the 25th day of each month thereafter, until paid in full, with the full privilege of anticipation, with interest thereon from date at the rate of six (6%) per cent, per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the eastern side of Ridgewood Drive, being shown and designated as Lot No. 7 on plat of Woodland Hills, recorded in Plat Book Y at Page 60, and described as follows:

"BEGINNING at an iron pin on the eastern side of Ridgewood Drive at the joint front corner of Lots Nos. 8 and 7, and running thence with the line of Lot 8 N. 73 E. 160 feet to an iron pin; thence S. 17 E. 43.3 feet to an iron pin; thence S. 43 W. 184.7 feet to iron pin in Ridgewood Drive; thence with the eastern side of Ridgewood Drive N. 17 W. 135.1 feet to the point of beginning."

Being the same premises conveyed to the mortgagors by deed of Richard C. Rudisill and Frances Rudisill to be recorded herewith.

This mortgage is junior in lien to a mortgage executed by the mortgagors to Fidelity Federal Savings & Loan Association in the amount of \$9450.00 of even date.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
