I, Hohn H. Tooley

All that piece, parcel or lot of land in Chick Springs Township, County of Greenville, State of South Carolina, located near Fairview Baptist Church, lying on the South side of State Highway No. 415 (also known as the Fairview Church Road), on the Northeast side of the Buncombe Road, bounded on the East by lands of Mrs. Nell M. McWilliams and on the West by lands of Mrs. Lessie M. Vaughn, and being all of the property on a plat made for Thomas Dewey Vaughn by H.S. Brockman surveyor, dated November 28, 1955, plat recorded in Greenville County R.M.C. Office, and having the following metes and bounds according to said plat.

BEGINNING at a stake on the south side of said highway, at the corner of Mrs. Nell M. McWilliam's land and running thence S. 59-08 W. 335 feet along the South side of said highway to a stake on the South side of said highway at the corner of Mrs. Lessie M. Vaughn Property; thence S. 8-12 E. 170 feet along the line of the Lessie M.
