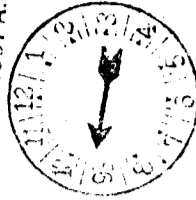

To All Whom These Presents May Concern:

I, **T.C. Rollins**

SEND GREETING:

Whereas, I, the said **T.C. Rollins**
in and by **my** certain **promissory** note in writing, of even date with these
Presents, **am** well and truly indebted to **B.P. Edwards**
in the full and just sum of **One hundred ninety-seven and 25/100- - - -**
(197.25)- - - -; to be paid **\$10.00** per month until paid in full

, with interest thereon from **date**
at the rate of **seven** per centum per annum, to be computed and paid **annually** from **date hereof**
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in the former School District
of **Ansel**, Chick Springs Township, Greenville County, State of South
Carolina, lying on the Southwest side of **Ansel School Road** and having
the following distances:

BEGINNING at a pen at the South West Corner of **T. C. Rollins** line S.
89-54 W. 1094 feet to a stake across the branch; thence **S. 23-23 E. 250**
feet to a stake; thence **N. 89-54 E. 1100** feet to old unpaved road; thence
down the unpaved road **N. 30 W. 00 250** feet to the point of beginning
at the corner of **T. C. Rollins** line and containing five (5) acres more or
less.
