To All Whom These Presents May Concern:

I, ELIZABETH ANN NELLIGAN, SEND GREETING:

Whereas, I, the said Elizabeth Ann Nelligan  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to Commercial Credit Corporation  
in the full and just sum of Ten Thousand and No One Hundredths Dollars  
(\$10,000.00), to be paid on demand

, with/interest thereon from  
at the rate of per centum per annum, to be computed and paid

until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Commercial Credit Corporation, its successors and assigns, forever:

All that piece, parcel or lot of land in the State and County aforesaid,  
in Gantt Township being known and designated as Lot No. 2 of a subdivi-  
sion known as Springview as shown on a plat thereof recorded in the  
R. M. C. Office for Greenville County in Plat Book "BE", at page 161,  
having, according to said plat the following courses and distances, to-  
wit:

BEGINNING at an iron pin on the East side of Air Base Road, at the joint  
corner of Lots 1 and 2 and running thence along the Eastern side of Air  
Base Road, S. 1-02 E. 89 feet to an iron pin; thence in a curved line  
around the intersection of Air Base Road and Farley Avenue, the arc of  
which is S. 46-07 E., 35.3 feet to an iron pin on Farley Avenue; thence  
with the Northern side of Farley Avenue, N. 88-54 E. 175 feet to an iron  
pin; thence with the joint line of Lots 2 and 3, N. 1-02 W. 113.9 feet  
to an iron pin; thence with the joint line of Lots 1 and 2, S. 88-58 W.  
200 feet to the beginning corner.
