(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Eight Thousand and no/100---

DOLLARS (\$ 8,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Fountain Inn known as lot no. 2 on plat of Property of Floyd and Mary W. Weathers made by W. J. Riddle, March, 1952 and recorded in Plat Book DD at Page 99 and in Plat Book FF at Page 350, which plats are identical as to this lot, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Weathers Circle, at the joint front corner of lot nos. 1 and 2 and running thence along the line of lot no. 1, S 67 E, 147.1 feet to an iron pin; thence N 19-18 E, 80 feet to an iron pin at the rear corner of lot no. 3; thence along the line of lot no. 3, N 67-02 W, 144.6 feet to an iron pin on Weathers Circle; thence with said Circle, S 21-04 W, 80 feet to the point of beginning and being the same property conveyed to the mortgagor in deed book 553 at page 49.
