in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The Peoples National Bank of Greenville, S. C., as Trustee, under agreement with Ernest Folger dated November 26, 1941, its successors and assigns forever:

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, in School District 161, near Welcome Schoolhouse, lying on the east side of White Horse Road and being known and designated as Lot No. 20 of the Property of J. R. Yown as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book H, at Page 49, and having the following metes and bounds, to-wit:
