NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in the City of Greenville, on the Southeastern side of East North Street Extension, sometimes called Spartanburg Road, being known and designated as Lot No. 2 on Plat of College Heights recorded in the R.M.C. Office for Greenville County in Plat Book P, at page 75, and having, according to said Plat, the following metes and bounds. to-wit:

BEGINNING at a point on the Southeastern side of East North Street Extension, joint front corner of Lots Nos. 1 and 2, said point being 134 feet from the Southeastern intersection of East North Street Extension and Erskine Street, and running thence S. 33-10 E. 200 feet to a point; thence N. 56-50 E. 75 feet to a point; thence N. 33-10 W. 200 feet to a point on East North Street Extension; thence with East North Street Extension, N. 56-50 W. 75 feet to the point of beginning.
