WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Seven Hundred -----

DOLLARS (\$ 700.00), with interest thereon from date at the rate of **Six (6%)**

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the west side of Lanford Street and the north side of Bennett Avenue, designated as Lot No. 58 of Westmoreland Circle, plat recorded in Plat Book T, page 198, R.M.C. Office for Greenville County, and being further shown by plat of H.S. Brockman, Surveyor, dated June 5, 1942, and having the following courses and distances, to-wit:

BEGINNING at the intersection of Lanford Street and Bennett Avenue, and running thence along Lanford Street, N. 4.35 E. 142.5 feet to iron pin, corner of Lot No. 59; thence N. 85.20 W. 197.8 feet to iron pin on Green Street; thence along Green Street, S. 13.45 W. 15 feet to Bennett Avenue; thence along Bennett Avenue, S. 52.40 E. 237.3 feet to the beginning corner.
