We, John B. Anderson and Lonna Anderson, SEND GREETING:

Whereas, we, the said John B. Anderson and Lonna Anderson,  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to John A. Park,  
in the full and just sum of FIVE HUNDRED and no/100 (\$500.00) DOLLARS,

, to be paid as follows: Five (\$5.00) Dollars on May 18,  
1957, and a like sum on the 18th day of each and every succeeding Calen-  
dar month thereafter, until paid in full; with the right to anticipate  
by the payment of all or any part thereof at any time before maturity,

, with interest thereon from date  
at the rate of 7 per centum per annum, to be computed and paid semi-annually  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Greenville County, State of South Carolina, on the northern side of the  
Standing Springs Road, being shown and designated as Lot Number Six  
(No. 6) on a plat of "Air Base Farms" recorded in Plat Book "U" at page  
199 in the R.M.C.office, and, according to said plat, having the follow-  
ing metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of Lot No. 5, and run-  
ning thence with the line of Lot No. 5, N. 20-02 E. 293.7 feet to a  
stake; thence with the line of Conestee property, S. 64-29 E. 90 feet  
to pin at corner of Lot No. 7; thence with line of Lot No. 7, S.18-08 W.  
288.8 feet to pin on Standing Springs Road; thence with said Road,
