WE, JERRY CALDWELL AND PEGGY CALDWELL of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in the County of Greenville, State of South Carolina, being all of Lot No. 4 and the eastern half of Lot No. 5, Block "A" on plat of Hughes Heights Subdivision, recorded in Plat Book GG, page 123 of the R.M.C. Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of West Parker Road, the front joint corner of Lots 3 and 4, Block A; thence with the line of said lots, S. 18-36 W. 150 feet to an iron pin in line of Lot No. 13; thence N. 71-24 W. 112.5 feet to an iron pin in the middle of the rear line of Lot No. 5; thence through the middle of said lot, N. 18-36 E. 150 feet to an iron pin on the southerly side of west Parker Road; thence with the southerly side of West Parker Road, S. 71-24 E. 112.5 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
