TO ALL WHOM THESE PRESENTS MAY CONCERN:

Charles B. Masters and Betty Jean Masters (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

THREE THOUSAND TWO HUNDRED TEN AND NO/100----- DOLLARS (\$ 3,210.00 ),

with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid:

*M* \$75.00 on the 20th day of each month hereafter, commencing May 20, 1957, and continuing until paid in full, with interest thereon from date at the rate of six per cent, per annum, to be computed and paid semi-annually in advance, until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, in the Town of Travelers Rest, being shown as Lot No. 81, on plat of property of Ray E. McAlister made by Pickell & Pickell on October 16, 1948, as revised on February 24, 1949, and January 21, 1952, and in accordance with said revisions, it is described as follows:

BEGINNING at an iron pin on Forest Drive at joint front corner of lots 81 and 82, and running thence with the line of Lot 82, N. 2-00 W. 266 feet to an iron pin in a branch; thence, with said branch as a line, 103 feet to an iron pin at the corner of Lot 93; thence with the line of said lot, S. 2-00 E. 240 feet to an iron pin on Forest Drive; thence with the Northern side of said drive, S. 88-00W 100 ft. to the beginning corner.
