TO ALL WHOM THESE PRESENTS MAY CONCERN:

J. R. MOORE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Sixty-nine Hundred and No/100 - - - - -
DOLLARS (\$ 6900.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, containing 5.92 acres, more or less, and being tracts 1 and 2 of the property of J. B. Granger, according to survey made by W. J. Riddle, May 7, 1940, and when described together, have the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Grove Road at the corner of property now or formerly owned by Lewis Metcalf, and running thence with the line of said property N. 84 E. 808.8 feet to iron pin; thence N. 10-10 E. 261.7 feet to road leading from Grove Road to White Horse Road; thence along said road N. 79-10 W. 651.4 feet to a pin in center of Grove Road; thence along the center of Grove Road S. 24-17 W. 512.2 feet to beginning corner; said premises being the same conveyed to the mortgagor by deed recorded in Deed Book 269 at Page 233."

Less, however, that certain lot of land conveyed by J. R. Moore to Joel I. Spears by deed dated June 28, 1954, recorded in Deed Book 503 at Page 13.
LESS, HOWEVER, that certain lot conveyed to Charles Adams and Jean Moore Adams by deed recorded in Deed Book 522 at Page 177, and less, however, that other lot of land conveyed to Joel I. Spears by deed recorded in Deed Book 563 at Page 115.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
