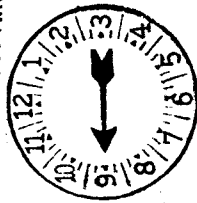

To All Whom These Presents May Concern:

SEND GREETING:

Whereas, I , the said **H. B. Davis**  
 in and by **my** certain **promissary** note in writing, of even date with these  
 Presents, **am** well and truly indebted to **Vance E. Edwards**  
 in the full and just sum of **Three Hundred and Eight (308.00) and no/100 Dollars**  
 , to be paid **Twenty-five (\$25.00) per month beginning**  
**May 16, 1957 until paid in full**

, with interest thereon from **maturity**  
 at the rate of **7** per centum per annum, to be computed and paid  
**at maturity** until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

**Vance E. Edwards, his heirs and assigns:**

All those certain pieces, parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Southwestern side of White Horse Road, near the Town of Travelers Rest, and described as follows:

BEGINNING on an iron pin in the White Horse Road, and running thence with said road, S. 48 W. 1.57 chains to iron pin; thence S. 44-30 E. 6.32 chains to iron pin on railroad; thence N. 20 E. 1.70 chains to iron pin; thence N. 44-30 W. 5.65 chains to the point of beginning, containing 9/10 acre, more or less.

Being the same property conveyed to the mortgagor by deed recorded in Volume 235 at page 243.

BEGINNING at an iron pin on the South Side of White Horse Road, and running thence with said road, S. 46 W. 1.85 chains to iron pin; thence S. 44-30 E. 5.65 chains to iron pin on G. & N. Railway; thence N. 20-00 E. 2.08 chains to an iron pin on said railroad; thence N. 44-30 W. 4.00 chains to the point of beginning, and containing 95/100 acres, more or less.
