To All Whom These Presents May Concern:

SEND GREETING:

Whereas, the said **MARSMEN, INC.**  
a corporation chartered under the laws of the State of South Carolina, in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to Helen L. Terry in the full and just sum of **THREE THOUSAND AND NO/100 (\$3,000.00) DOLLARS**  
, to be paid \$50.00 on May 23, 1957 and \$50.00 on the 23rd of each and every month thereafter until April 23, 1960 when the balance of principal and interest shall be due and payable. From each monthly payment interest shall be first paid and the balance credited as a principal reduction  
, with interest thereon from date  
at the rate of **six** per centum per annum, to be computed and paid **monthly**  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Helen L. Terry according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to it the said **MARSMEN, INC.**  
, in hand well and truly paid by the said Helen L. Terry at and before the signing of these Presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released and by the Presents does grant, bargain, sell and release unto the said Helen L. Terry, her Heirs and Assigns forever;

All those four certain pieces, parcels or tracts of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Tracts Numbers 275, 276, 277 and 278 on a plat of Augusta Acres, property of Marsmen, Inc., recorded in the R. M. C. Office for Greenville County in Plat Book "S", Page 201 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Churchill Circle, joint corner of Tracts 274 and 275 and running thence with line of Tract 274, N. 35-3 E. 592 feet to a stake on Reedy River; thence with Reedy River as the line in a Northwesterly direction 950 feet, more or less, to a stake; thence S. 58-22 W. 820 feet to an iron pin, joint corner of Tracts 278 and 279; thence with line of Lot 279, S. 8-16 E. 679.1 feet to an iron pin on the North side of Churchill Circle; thence with Churchill Circle, N. 81-44 E. 300 feet to an iron pin; thence still with Churchill
