WHEREAS:

I, LONNIE MAX COLE

Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

AIKEN LOAN & SECURITY COMPANY

a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand Four Hundred and no/100 Dollars (\$10,400.00), with interest from date at the rate of four and one-half per centum (4½%) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty-seven and 82/100 Dollars (\$ 57.82), commencing on the first day of June, 19 57, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 82.

All that lot of land in the County of Greenville, State of South Carolina, designated as Lot No. 62 on plat of Casa Loma Estates, recorded in Plat Book "S" at Page 65 of the R.M.C. Office for Greenville County, S. C., and having according to said plat and a recent survey made by R. W. Dalton, March 1957, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwest side of Courtney Circle, the front joint corner of Lots Nos. 62 and 63; thence with the joint line of said lots, N. 70-50 W. 218.2 feet to an iron pin (tel. pole), corner of Lot No. 60; thence with the line of said lot, S. 25-0 E. 108 feet to an iron pin, corner of Lot No. 61; thence with the line of said lot, S. 70-50 E. 143.2 feet to an iron pin on the northwest side of Courtney Circle; thence with the northwest side of Courtney Circle, N. 19-10 E. 80 feet to the beginning corner.
