interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,

County, State of South Carolina, and having according to a plat by
Robert Jordan, Reg. Surveyor, dated April 23, 1957, the following
metes and bounds, to wit:

Washington; thence S. 28-40 W. 262 feet to an iron pin on the line of
