To All Whom These Presents May Concern:

I, Addie Lucille Benston, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Three Thousand, Fight Hundred, Fifty & No/100- -

(\$ 3.850.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of

Thirty-Fight and 50/100 - - - - - - - (\$ 38.50) Dollars
upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest
has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the
unpaid balance, and then to the payment of principal. The last payment on this mortgage, if not sooner paid, will
be due and payable Eleven (11) years after date. The note further provides that if at any time any portion
of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure
to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole
amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder
may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee
beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as
a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as
in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, just outside the corporate limits of the City of Greenville on the southeast side of Grove Road, and being known and designated as Lot No. 8, of Block N, of the property of O. P. Mills as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book C, at page 176, and baving the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeast side of Grove Poad at the joint corner of Lots Nos. 8 and 9, of Block N, which point is 245 feet from the southwest corner of the intersection of Grove Poad and Augusta Road (as laid out on said plat), and running thence along the joint line of said lots, S. 47-52 E. 180 feet to an iron pin at the joint rear corner of said lots in the line of a lot belonging to the City of Greenville; thence along the line of the City lot, S. 45-27 W. 60 feet to an iron pin at the joint rear corner of Lots Nos. 7 and 8, of Block N; thence along the joint line of said lots, N. 47-52 W. 180 feet to the joint corner of said lots on the southeast side of Grove Road; thence along the line of said Grove Road, N. 45-27 E. 60 feet to the beginning corner; and being the same conveyed to me and Minnie Elizabeth Benston by Wycliffe Pobinson by deed dated July 12, 1945 and recorded in the R. M. C. Office for Greenville County in Vol. 277 at page 439. Minnie Elizabeth Penston Richardson, formerly Minnie Elizabeth Benston, conveyed her one-half interest to me by deed dated July 19, 1952, and recorded in the R. N. C. Office for Greenville County in Deed Vol. 459, at Page 315."
