WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-five Hundred and No/100 - - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 90 on plat of Nickletown Heights recorded in Plat Book M, Page 4, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of Bridwell Avenue, joint front corner of Lots 90 and 91 and running thence with the line of Lot 91 N. 89-15 E. 110 feet to pin in line of Lot 104; thence N. 0-45 W. 40 feet to pin at corner of Lot 89; thence with the line of Lot 89 S. 89-15 W. 110 feet to pin on Bridwell Avenue; thence with Bridwell Avenue S. 0-45 E. 40 feet to the beginning point."
