We, Deacons of Southside Baptist Church, Piedmont, S. C. SEND GREETING:
Whereas, We, the said Deacons of Southside Baptist Church, Piedmont, S. C.
in and by our certain promissory note in writing, of even date with these
Presents, we are well and truly indebted to Bank of Piedmont
in the full and just sum of (\$3,281.45) Three thousand Two Hundred Eighty-one and 45/100
, to be paid Payable one year from date

, with interest thereon from maturity
at the rate of 6 per centum per annum, to be computed and paid in advance
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Grove Township, Greenville County, State
of South Carolina, containing twenty-seven one-hundredth of one acre (27/100)
more or less, lying on the west side of Highway #29 in Rehobeth School District
having the following courses and distances to wit:

BEGINNING at a stake joint corner of Ed Boyce and C. W. Locke, thence
N 87 1/2 W 84 feet to a stake, thence N 36 W 126 feet 8 inches to iron pin,
thence S 87 1/2 E 175 feet 10 inches to a stake, thence S 8 W for 97 feet to
the point of origin.
