To All Whom These Presents May Concern

----- JAMES M. TUTEN AND RUTH G. TUTEN -----
hereinafter spoken of as the Mortgagor send greeting.

Whereas ----- JAMES M. TUTEN AND RUTH G. TUTEN -----
is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the
State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of -----
----- TEN THOUSAND AND NO/100 ----- Dollars

(\$ 10,000.00), lawful money of the United States which shall be legal tender in payment of all
debts and dues, public and private, at the time of payment, secured to be paid by that one certain note
or obligation, bearing even date herewith, conditioned for payment at the principal office of the said
C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without
the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of
----- TEN THOUSAND AND NO/100 -----
----- Dollars (\$ 10,000.00)

with interest thereon from the date hereof at the rate of 5-1/4 per centum per annum, said interest
to be paid on the 1st day of July 19 57 and thereafter said interest
and principal sum to be paid in installments as follows: Beginning on the 1st
of August 19 57, and on the 1st day of each month thereafter the
sum of \$ 107.30 to be applied on the interest and principal of said note, said payments to continue
up to and including the 1st day of June 19 67, and the balance
of said principal sum to be due and payable on the 1st day of July 19 67;
the aforesaid monthly payments of \$ 107.30 each are to be applied first to interest at the rate
of 5-1/4 per centum per annum on the principal sum of \$ 10,000.00 or so much thereof as shall
from time to time remain unpaid and the balance of each monthly payment shall be applied on account
of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being
thereby expressly agreed that the whole of the said principal sum shall become due after default in the pay-
ment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

even, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and
being in the City of Greenville, County of Greenville, State of South Carolina,
being known and designated as Lots Nos. 83 and 84, of North Park Subdivision, as per
plat thereof recorded in Plat Book M, at Pages 48 and 49 in the R.M.C. Office for
said county; said lot having a frontage of 134 feet on the East side of North Main
Street, a depth of 167 feet on the South, 166.6 feet on the North, and 134 feet
across the rear.
