I, Grace G. Huff

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Five Thousand and No/100- - - - -**

DOLLARS (\$ 5000.00), with interest thereon from date at the rate of **Five & One-Half** per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the South side of Perry Avenue, being shown as lot # 8, Block 1, on Page 80 of the City Block Book, being more particularly described as follows:**

"BEGINNING at the corner of lot now or formerly owned by E. Inman, which point is 70 feet from Memminger Street, and running thence with Perry Avenue, S. 71-06 E. 60 feet, more or less, to iron pin, corner of Orr lot; thence with the line of said lot, S. 16 W. 150.2 feet; thence N. 71-06 W. 68.1 feet to iron pin; thence N. 19-10 E. 150 feet to the beginning corner on Perry Avenue."

Being the same property conveyed to P. C. Garrison by Emma V. Clifton by deed recorded in Volume 41 at Page 105, and devised by the Will of P. C. Garrison filed in Apartment 195 at Page 1 to C. W. Garrison for life, then to his children, and Virginia Garrison Lindler having conveyed her undivided one-half interest therein to the mortgagor by deed recorded in Volume ___ at Page ____.
