WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Ten Thousand Five Hundred and no/100---

DOLLARS (\$ 10,500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, located on the northwest side of Helen Street near the Town of Simpsonville, being known and designated as Lot No. 57 in the subdivision known as Gresham or Forest Park, plat of said subdivision being recorded in Plat Book "EE" at pages 64 and 65 in the Greenville County R.M.C. Office and being more fully described as follows:

BEGINNING at an iron pin on northwest side of Helen Street, joint corner with Lot No. 56, and running thence along line of Lot No. 56, N. 28-20 E. 140 feet to iron pin; thence S. 61-40 E. 90 feet to iron pin; thence along line of Lot No. 58, S. 28-20 W. 140 feet to iron pin on Helen Street; thence along Helen Street N. 61-40 W. 90 feet to the beginning corner.
