United States of America, and his successors in such office, as such, and his or their assigns, hereinafter called
Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated
herein by reference, in the principal sum of NINE THOUSAND, FIVE HUNDRED AND NO/100 - - - - -
- - - - - Dollars (\$ 9,500.00), with interest from date at the rate of
four and one-half per centum ($4\frac{1}{2}$ %) per annum until paid, said principal and interest being payable
at the office of the Loan Guaranty Officer, Veterans Administration Regional Office, at Columbia, South
Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the
Mortgagor, in monthly installments of Fifty Two and 81/100 - - - - - Dollars
(\$ 52.81), commencing on the 20th day of July, 1957,
and continuing on the 20th day of each month thereafter until the principal and interest
are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the 20th day of June, 1982.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the
Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these
presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released,
and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, and unto his successors
in such office, as such, and his or their assigns, the following described property, to-wit:

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot No. 18 on Plat of

South Carolina, in Plat Book "P", at Page 1, and having, according to said plat, the
following metes and bounds, to-wit:

front corner Lots 17 and 18, and running thence N. 18-04 W. 247.6 feet to an iron
pin, joint rear corner Lots 17 and 18; thence N. 68-18 E. 86.4 feet to an iron pin,

East View Drive, joint front corner Lots 18 and 19; thence along East View Drive
